Detailed Time Table will be published in the University Office, Information Centres, Examination Centres and in the University Web site.

1. Candidates should remit a C.V. Camp fee at the rate of Rs. 50/- per paper subject to a maximum of Rs. 200/- and Rs.30/- towards online registration fee in addition to the normal examination fee.
2. Transitory candidates should remit a C.V. Camp fee at the rate of Rs. 50/- per paper subject to a maximum of Rs. 200/- in addition to the normal examination fee. Transitory candidates should submit their applications directly to the University.
3. Sessional Improvement candidates registering for the examination should remit a C.V. Camp fee at the rate of Rs. 50/- per paper subject to a maximum of Rs. 200/- and Rs.1000/- (Rupees One thousand only) as additional fee in addition to the normal examination fee.
4. Candidates registering under Mercy Chance for the examination should remit Rs. 2000/- towards Mercy Chance fee and CV Camp fee at the rate of Rs. 50/- per paper subject to a maximum of Rs. 200/- in addition to the normal Examination fee. The Examination will be conducted for the failed candidates who had their admission to the B.Tech course up to 2005 admission. The Examination will be conducted in 2008 Scheme under transitory provision. The candidates shall also apply to the failed subjects of other semesters, if any falling as transitory in the Combined First & Second, Fourth and Sixth Semesters (2008 Scheme). The candidates should submit the details regarding the year of admission, Register number/Month & year of previous appearances and the names of the subject of the parent scheme for which the candidate intends to appear under transitory provision along with the application form and prescribed fee.
