It is hereby notified for the information of all concerned that University has granted a Mercy Chance examination to all the failed candidates of five year LL.B Degree Course (2001 admissions) and those who wish to appear for the **First Year LL.B. and Second Year LL.B. (Mercy Chance – Five Year Course – New Scheme – 1998 Scheme – 2001 Admission) Degree Examinations, May 2020** should submit their application along with the prescribed fee for the examinations as follows

Candidates should submit separate applications for each year and remit fee separately for each application including Mercy Chance fee.

Date of Commencement of Examinations will be announced later. Detailed Time Table will be published in the University Office, Information Centres, Examination Centres and in the University Web site.

Candidates registering for the examination should remit Rs. 10000/- towards Mercy Chance fee if the papers is three or less and Rs.2500/- per paper if the number of papers is more than three in addition to the normal Examination fee. Candidates should also remit CV Camp fee of Rs.300/- in addition to the normal Examination fee.

P.T.O.

Only candidates who have registered and appeared for the Final year examination are eligible for applying for Mercy Chance. Applications have to be supported by photocopies of marklists of previous appearances, which is mandatory. Candidates should specify whether they have undergone Regular or Evening batch.

5% of increase in the fee/charges should also be remitted by the candidates registering for the examination as per U.O. No. Ad.A5.03/9871/2019 dated 01.04.2019.
