Detailed Time Table will be published in the University Office, Information Centres, Examination Centres and in the University Web site. Candidates registering for the Examination should remit a CV Camp fee of Rs.300/- in addition to the normal Examination fee. Those candidates who have completed 5 years after the completion of the LL.B Degree course are not eligible to apply for the examination.

Candidates who are granted Mercy Chance Examination for LL.B. Course (3 year – 2004, 2005, 2006, 2007, 2008 , 2009 & 2010 admissions) and LL.B course (5 year-2002 ,2003, 2004, 2005, 2006, 2007 & 2008 admissions) should remit Rs.7500/- towards Mercy Chance fee if the number of papers is three or less and Rs. 2500/- per paper as Mercy chance fee if the number of papers is more than three and CV Camp fee of Rs.300/- in addition to the normal Examination fee.
